European Tourism Sustainability Monitoring 2030 (ETSM2030) is a project co-funded by the European Commission under the Single Market Programme, supporting the sustainability activity of European small and medium-sized tourism enterprises. This Call for Proposals sets out the rules for submission and selection of third parties (SMTEs) that will receive financial support under the project.

The content of this Call for Proposals conforms with the "Guidelines for awarding financial support to third parties" established in relation to the funding programme SMP-COSME-2021-TOURSME of the European Commission, under which the ETSM2030 project is funded (Grant Agreement no. 101085883), particularly section 2, and the ETSM2030 Grant Agreement, particularly articles 5, 6 and 9.

This re-opening of the Call aims to find six motivated, eligible companies from Germany for the ETSM2030 project to fill in the vacant spot in the ETSM2030 project and to establish a decent reserve list. The best rated company (see chapter 4 for the evaluation process) will fill in the vacant spot in the ETSM2030 project, whereas the remaining companies will be added to the reserve list.

#### 1.1. Key project facts



#### 1.2. How the project works

On the one hand, the project consists of a bundle of activities for which the selected SMTEs receive financial support (step 3, 4, 6, and 7). On the other hand, the project consortium offers direct services to the SMTEs which create additional value for the SMTEs.

Since the Call is re-opened, for the new joining German company the project duration will start after signing the Service Agreement and run until 31 December 2025.

Since the Call is re-opened with 10 April 2024, the initially foreseen time-frame will be adjusted to the new entering company and can be illustrated as follows:

Currently 83 companies are already participating in the ETSM2030 project, whereas 80 companies are in the project right from the beginning and three joined the project later.

#### 1.3. The project's consortium

The project is run by the international consortium created by the following partners representing six European countries: <u>University of Innsbruck</u> (Austria), <u>IMC Krems</u> (Austria), <u>Centre of Business Excellence (CBE)</u> (Slovenia), <u>Eurac Research</u> (Italy), Poznań University of Economics and Business (Poland), <u>RoMontana</u>, <u>National Association for Rural and Mountain Development</u> (Romania), <u>TourCert</u> (Germany), and <u>TVB Innsbruck</u> (Austria).

### 2. Why SMTEs should apply

#### 2.1. Benefits for selected SMTEs

Applying to ETSM2030 can bring to selected SMTEs financial support and many managerial benefits in the area of sustainability performance. During the project, selected SMTEs will be encouraged to meet the following objectives:

- Involvement in the assessment of prior sustainability awareness, monitoring and practices;
- Improvement of SMTEs' knowledge level about sustainability monitoring and practices;
- Development of self-evaluation sustainability monitoring tool suitable for selected SMTEs to be integrated in daily routines;
- Co-creation of sustainability innovation projects together with other participating SMTEs;
- Preparation and application for sustainability certifications (in particular EU Ecolabel and EMAS);
- Participating in a network of SMTEs devoted to sustainability monitoring and practices (SESTINE).

#### 2.2. Activities eligible for receiving financial support

Following the call objectives, selected SMTEs will receive financial support for the following eligible activities:

Fitness check of practices and strategies, and their compliance with upcoming regulations

SMTEs' preparation and application for sustainability certification Implementation of the Environmental Footprint Methods as part of SMTEs' sustainability strategy development Development of the participating SMTEs' sustainability strategies and implementing the improvement measures following the recommendations of status quo studies regarding sustainability performance

Developing mechanisms for SMTEs to transparently share sustainability relevant data and information for use by consumers, national tourism offices and other tourism actors Upskilling and re-skilling of SMTEs on sustainability, digital innovation and data management using (online/hybrid) training and coaching

Boosting innovation in sustainable tourism by knowledge transfer and crosssectoral collaboration

Increasing the competitiveness of the participating SMTEs by improving its capacity and uptake of innovative sustainable solutions

Developing socially sustainable tourism models, considering the impact and participation of local communities and reducing problems of overtourism Developing sustainable businessstrategies in line with forward-looking market trends, to facilitate return of investment and the diversification of serviceoffers

#### 2.3. Criteria and modalities for awarding financial support

General information:

- Each selected SMTE can obtain up to approximately EUR 7.840 of EU funds through the project (given that exactly 84 SMTEs participate).
- The financial support is provided in the form of four fixed payments (see table below).
- The financial support to third parties cannot be used for the acquisition of services provided directly by the ETSM2030 consortium partners.

#### 3. How to apply

This section includes all the relevant information for successfully applying to the ETSM2030 Call for Proposals.

#### 3.1. Who can apply - Eligibility criteria

Any legal entity that fulfils the following conditions is allowed to submit its application for funding under the call:

1.1. Be a small or medium-sized enterprise (SME) as defined by the <u>EU recommendation</u> 2003/3612;

In this sense, start-ups, micro, small and medium-sized enterprises, same as any other type of SME falling under this definition are eligible to apply to the call.

#### 1.2. Be registered in Germany.

- 1.3. Be established for at least three financial years to be proved through the Company Registration Report;
- 1.4. Work in tourism, i. e. belong to one of these categories of the tourism industry (NACE classes and categories):
  - H4910 Passenger rail transport, interurban
  - H4932 Taxi operation
  - H4939 Other passenger land transport n.e.c.
  - H5010 Sea and coastal passenger water transport
  - H5030 Inland passenger water transport
  - H5110 Passenger air transport
  - I5510 Hotels and similar accommodation
  - 15520 Holiday and other short-stay accommodation
  - 15530 Camping grounds, recreational vehicle parks and trailer parks
  - I5610 Restaurants and mobile food service activities
  - I5630 Beverage serving activities
  - N7710 Renting and leasing of motor vehicles
  - N7721 Renting and leasing of recreational and sports goods
  - N79 Travel agency, tour operator reservation service and related activities
  - N8230 Organisation of conventions and trade shows

- R90 Creative, arts and entertainment activities
- R91 Libraries, archives, museums and other cultural activities
- R92 Gambling and betting activities
- R93 Sports activities and amusement and recreation activities

It is also a prerequisite that the applicants fulfil the following criteria:

- 1.5. Has not been declared bankrupt or has initiated bankruptcy procedures;
- 1.6. Be not under liquidation; an enterprise under difficulty accordingly to the Commission Regulation No 651/2014 art. 2.18.
- 1.7. Conducts activities that respect climate and environmental priorities of the EU and cause no significant harm to them [reference to EU horizontal principle].

All applicants must apply individually. It is not permitted to submit applications in partnership with other SMTEs. Only one application per SMTE is accepted.

Applying SMTEs have to agree to the Declaration of Honor (Annex 2), where the applying SMTE has to declare that it is not in any of the above-mentioned situations. Selected SMTEs have to sign the Service Agreement which defines eligible activities for both parties (Annex 5) within 3 weeks after acceptance notification. If a selected SMTE fails to sign the service agreement it will be put on the reserve list.

#### 3.2. Application procedure

All applicants are requested to:

- Apply online through the dedicated page (<a href="https://www.etsm2030.eu/">https://www.etsm2030.eu/</a>). Applicants shall register on the platform to access the ETSM2030 call for proposals page and the application package.
- It is recommended to fill in an application in the English language. Due to the fact that applicants would be non-native English speakers, the applications will not be evaluated based on the use of language but on the provided content. Please be clear and precise in the explanations provided in the project proposal.
- Fill in the administrative and technical information requested in the online AF on the platform.
- Complete the online application and submit all the documents requested. Applicants who fail to do so will not be considered admissible.

Proposals are admissible only if they meet the following criteria:

- Only one application per applicant can be submitted for this Call for Proposals. In the case of submissions by the same applicant of different proposals or multiple submissions of the same proposal, only the last one received will enter the evaluation process; the rest will be declared as non-admissible.
- Only proposals submitted before the deadline will be accepted. The deadline for this call is Wednesday 8 May 2024, at 17:00 CET (Brussels time).

- Only complete proposals, including all the required information and documentation, will be accepted.
- Only proposals submitted through the below indicated online submission form will be accepted. Paper/printed versions or hand-written versions submitted by post or other means will not be accepted.

The call for proposals will be open from Wednesday 10 April 2024 to Wednesday 8 May 2024 at 17:00CET (Brussels time). Applications submitted after the deadline will not be accepted and will receive by return e-mail a "call closed" message. Potential applicants are invited not to wait until the last moment to apply. The time of receipt of the application, as recorded by the submission system, will be definite.

#### 3.3. Application form

The structure and content of the Application Form are presented in Annex 1, together with the general instructions for filling in the application form.

The application form is divided into the following parts:

- 1. Information about the applying SMTEs
- 2. The outline of SMTEs' sustainability practices
- 3. SMTE's information on its willingness to implement cutting-edge developments
- 4. SMTE's information on its ability to network with other stakeholders in their destinations and their influence on other members of the ecosystem
- 5. Attachments

In part 1, the applicants are required to provide all the listed information, including:

- company name,
- company address,
- region and country,
- VAT or TAX number,
- bank name and address,
- legal representative,
- average number of employees (financial year 2022),
- turnover (2022),
- class of registered business activity,
- webpage (if available),
- social media pages (if available).

In part 2, the applicants are asked to indicate what sustainability-oriented actions or practices they have implemented in their SMTE. The answer can refer to (1) environmental, (2) social and/or (3) economic sustainability.

In part 3, the applicants' willingness to implement cutting-edge developments is assessed. Therefore, in this part, the applicants should describe the following:

How COVID-19 has impacted their sustainability activities, and

In part 4, the applicants are asked to indicate what tourism-or destination-based collaborative bodies or partnerships they are members of.

In part 5, the applicants can attach any documents supporting the application.

#### 3.4. Further Information for Applicants

#### 4. Evaluation and selection process

This section includes information about the evaluation and selection process ETSM2030 will carry out. An independent Selection and Evaluation Committee will manage and supervise the process, ensuring fairness and transparency. The evaluators will generate a ranked list using the overall scores for each application.

The evaluation will happen in the following way:

- Formal eligibility check of proposals
- Technical evaluation with appointed experts
- Selection procedure

#### 4.1. Check for Proposal Eligibility

Before proposals are evaluated technically, their administrative eligibility is verified. Only eligible submissions will be evaluated. The eligibility criteria, as referred to in section 3, will be applied to discard non-eligible proposals.

Non-eligible proposals will get a rejection letter with the proper decision justification.

#### 4.2. Evaluation criteria

Eligible applications will be evaluated against predetermined evaluation criteria, applying predefined score points. These criteria are listed below and will be applied to discard non-eligible proposals.

The applicants will be requested to explain their sustainability monitoring needs/status quo in terms of:

- sustainability practices,
- willingness to implement cutting-edge developments,
- ability to network with other stakeholders in their destinations and their influence on other members of the ecosystem.

Moreover, the applicants shall explain how the training and advisory support and joint international sustainable innovation projects (SIP) will meet their needs and will support them in the process of recovery after COVID-19.

For each criterion marks from 0–5 points are given, which means that the maximum score is 15 points, but having 0 in one of the criteria does not exclude the proposal. Those proposals which pass the threshold of 5 points are included in the further evaluation process while those with lower than 5 points are rejected. Although passing the threshold does not mean that the project will be funded. The ranking is separately listed for each individual territory.

#### 4.3. Selection of the participating SMTEs

Applying SMTEs will be selected based on the scores achieved in the Evaluation Form (Annex 3). The selection committee consists of two industry experts and two scientific experts in sustainable management and monitoring.

Ranking of proposals based on SMTEs overall score: max 15 points to achieve.

In case of the same SMTEs' score and position in the ranking, the following priority rule will be used: (1) the score in C2 Willingness to implement cutting-edge developments, (2) the score in C3 Ability to network; and (3) the score in C1 Sustainability practices.

One week after closing the call each applicant will be informed via e-mail of the (1) acceptance, (2) inclusion in the reserve ranking list or (3) rejection of the application. Moreover, the name of selected SMTEs will be published at the ETSM2030 website.

#### 4.4. Redress Process

Within 3 working days of the delivery of a rejection letter considering the proposal as ineligible, the proposer may submit a request for redress if they believe the results of the eligibility checks have not been correctly applied.

In that case, an internal review committee of the ETSM2030 Consortium will examine the request for redress. The committee's role is to ensure a coherent interpretation of such requests, and equal treatment of applicants. Requests must be:

- Related to the evaluation process or admissibility/eligibility checks;
- Clearly describe the complaint;
- Received within the time limit (3 working days) from the reception of a rejection letter considering the proposal as ineligible or the Selection Report information letter delivered;
- Sent by the SME that has also submitted the proposal.

The committee will review the complaint and will recommend an appropriate course of action. If there is clear evidence of a shortcoming that could affect the eventual funding decision, it is possible that all or parts of the proposal will be re-evaluated. Please note:

- This procedure is concerned only with the evaluation and/or admissibility/eligibility checking process. The committee will not call into question the scientific or technical judgment of appropriately qualified experts;
- A re-evaluation will only be carried out if there is evidence of a shortcoming that affects the final decision on whether to fund it or not;

- The evaluation score following any re-evaluation will be regarded as definitive. It may be lower than the original score;
- Only one request for redress per proposal will be considered by the committee. All requests for redress will be treated in confidence and must be sent to the Open Call coordinator via email to etsm2023@uibk.ac.at

#### 5. Processing of personal data, confidentiality, and communication

The reply to this call involves consent to collecting, recording and processing of all personal data (name, address, etc.). Such data will be processed pursuant to Regulation (EU) 2016/679 on the protection of natural persons with regard to the processing of personal data.

According to articles 13-19 of the Grant Agreement (project number: 101085883), all the information submitted by the applicants will be handled only by the ETSM2030 project team involved in the Call for Proposals. The sender's identity and the proposal's content will be treated strictly confidential by the Selection and Evaluation Committee, who will perform the work impartially applying the highest ethical and moral standards. External evaluators will sign a declaration of confidentiality. The application will be stored on a web-based, password-protected collaborative platform to which only the ETSM2030 members will have access. Data regarding the proposal may also be exchanged between the ETSM2030 Selection and Evaluation Committee through corporate e-mail and the dedicated project communication platform. Confidential information disclosed by the applicant must be marked as confidential. The applicant shall disclose to the ETSM2030 consortium confidential information, in its sole discretion, if the applicant considers it necessary or desirable for the purpose of assessing the application.

The ETSM2030 consortium will strictly apply confidentiality rules as laid down in its consortium agreement and will not use confidential information of applicants for any purpose other than to meet the objectives of this Call for Proposals.

Any communication or publication made by participants or selected SMTEs under this CfP should clearly indicate that the development of the content, output, etc. has received funding from the EC within the scope of the ETSM2030 project (project number: 101085883) displaying the EU logo on all printed or digital material, including websites and press releases. The following disclaimer furthermore has to be visible:

"Funded by the European Union. Views and opinions expressed are however those of the author(s) only and do not necessarily reflect those of the European Commission or the European Innovation Council and SMEs Executive Agency (EISMEA). **AND**

## 1. Description of the Project

The European Sustainability Monitoring 2030 (ETSM2030) is a project co-funded by the EuropeanUnion (EU) to foster sustainability certification and sustainability knowledge within SMTEs as well as bring together sustainable working SMTEs in a network, where exchange is encouraged. The ETSM2030 project is part of the Single Market Programme, which is a European programme to support competitiveness amongst SMTEs within the EU.

ETSM2030 aims at establishing a network of tourism SMEs (SMTEs) to increase sustainability monitoring by co-creating and co-implementing sustainable innovations projects (SIP) and by boosting participation in relevant sustainable certification schemes, in particular the EU Ecolabel and EMAS.

The ETSM2030 project team sets criteria for the selection of 84 SMTEs, then the selection of the SMTEs will be made via an open call in six EU countries (Austria, Germany, Italy, Poland, Rumania, and Slovenia). ## 5. Financial Aspects and Payment Arrangements

The beneficiary SMTE will receive a maximum amount of € 7.840,-.

The payments to the SMTEs follow the lump sum approach, where for proving a certain result/achievement of objectives a payment can be claimed by the participating SMTEs. Within the maximum amount set out above, the beneficiary SMTE will be bound to participate in all eligible activities. The lump sumshave to be used for fulfilling the eligible activities and cannot be used to purchase services from the consortium partners. If a SMTE does not complete the planned eligible activities, it will not get the financial support foreseen. Payments will not be transferred to SMTEs without proof of eligible activities. If the SMTEs do not produce any eligible activities, they are excluded from the project.

In the following table these eligible activities and payments – participating SMTEs will receive after finishing the eligible activities – are explained. First of all, SMTEs must be aware of the time periods when their high involvement and workloads are required for the project. #### 6. Financial Audits and Controls

EISMEA will monitor that ETSM2030 beneficiaries, and the beneficiary SME comply with the conditions for Financial Support to Third Parties (FSTP) set out in Annex1 of the ETSM2030 Grant Agreement and may take any action foreseen by the Grant Agreement in case of noncompliance vis à vis the beneficiary concerned.

Moreover, EISMEA may at any time during the implementation of the ETSM2030 project and up to five years after the end of the project, arrange for financial audits to be carried out, by external auditors, or by the EC services themselves including the European Anti-Fraud office (OLAF).

The audit procedure shall be deemed to be initiated on the date of receipt of the relevant letter sent by the EC. Such audits may cover financial, systemic, and other aspects (such as accounting and management principles) relating to the proper execution of the grant agreement. They shall be carried out on a confidential basis.

The beneficiary SME shall make available directly to the EC all detailed information and data that may be requested by the EC or any representative authorised by it, with a view to verifying that the Grant Agreement is properly managed and performed in accordance with its provisions and that costs have been charged in compliance with it. The beneficiary SME shall keep all sub-project deliverables and the originals or, in exceptional cases, duly authenticated copies – including electronic copies – of all documents relating to the sub-project contract for up to five years from the end of the project. These shall be made available to the EC were requested during any audit under the Grant Agreement.
